Recipients will be required to attend the annual Revenue Professionals conference in Albury on 20-22 March 2024.

The recipient must sign a terms and conditions declaration upon receipt of the award.

INCLUSIONS

Successful recipients will receive full conference registration and paid accommodation on each night of the conference, and attend the Revenue Professionals Conference the year of induction into the Hall of Fame.
